### **2 Healy + 2 Devane = 4 New Books**

***CUDDY--PLUS ONE;***  
***OFF-SEASON AND OTHER STORIES;***  
***JUROR NUMBER ELEVEN;***  
***A STAIN UPON THE ROBE***

Two Jeremiah Healy short story collections are joining Healy alter-ego Terry Devane's newest books on the store shelves.

Crippen & Landru has just released *CUDDY--PLUS ONE*, the publisher's second collection of short stories featuring Healy's popular private investigator, John Francis Cuddy. Healy has written seventeen novels, thirteen of them Cuddy novels, and more than sixty short stories. The first Cuddy story collection, *THE CONCISE CUDDY*, was published in 1998 and, between them, the two collections contain seven of Healy's Shamus Award-nominated stories.

*OFF-SEASON AND OTHER STORIES* is also just out from Five Star, its publication marking the first time that Healy's non-Cuddy stories and novellas have been gathered and published as a group. Among the stories are "Next Season," "Rotten to the Core," and "The Safest Little Town in Texas."

*A STAIN UPON THE ROBE*, the third book in Healy's legal thriller series under the pseudonym Terry Devane, will be out from Penguin/Putnam in September. The series features the attorney team of Mairead O'Clare and Sheldon Gold, a duo that Publishers Weekly calls "a formidable, unpredictable and entertaining pair." *A STAIN UPON THE ROBE* deals with the team representing a Superior Court judge presiding over the worst of Boston's priest-rape trials.

The paperback of the second Devane book, *JUROR NUMBER ELEVEN*, was released in June and involves Mairead in the homicide of a juror from one of Shel's murder trials.
